CORRIGENDUM TO THE PROVISIONAL SELECT LIST DATED: 21.10.2024

1. In pursuance to the Notification dated: 21.01.2021 cited at reference(1), the recruitment process to fill up 545 posts of Sub-Inspector of Police (Civil) (Men & Women) including In-Service and Kalyana-Karnataka was initiated. The Endurance Test and Physical Standard Test of all the candidates, who had applied for selection to the above said posts was conducted. The written examination was conducted on 03.10.2021 to all the candidates, who had qualified in the Endurance Test and Physical Standard Test.

2. Whereas, as per the procedure laid down in the Cadre and Recruitment (Amendment) Rules, 2009, 2016 & 2020, after completing the above said process, the Provisional Select List in the order of merit of candidates equal to the number of vacancies notified, was prepared and published vide reference (2). After the publication of the provisional select list, unit wise provisional select list were published to conduct medical examination and document verification of the selected candidates by the concerned units. The units were informed to send the reports vide reference(3).

3. In the background of illegalities found in the recruitment process, the cases registered were investigated by CID. As per the recommendations made in the report of CID, the Government of Karnataka vide reference (4) decided to cancel the written examination conducted on 03.10.2021 and it was also decided to conduct re-examination. Aggrieved by the Government order dated: 29.04.2022, some of the selected candidates filed applications in the Karnataka State Administrative Tribunal, which came to be dismissed the order of the Karnataka State Administrative Tribunal was questioned in various writ petitions filed in Hon'ble High Court of Karnataka. The Hon'ble High Court of Karnataka after hearing the matter, upheld the Karnataka State Administrative Tribunal order vide reference (5). The Hon'ble High Court of Karnataka also directed as under:-

- (i) Writ Petitions are dismissed;
- (ii) To ensure fair re-examination, the State Government shall entrust the process of re-examination to an independent agency without charging any fresh fee to the candidates.
- (iii) No costs.

4. In compliance to the judgment dated: 10.11.2022 of the Hon'ble High Court of Karnataka, the Government of Karnataka vide reference (6) directed the Karnataka Examination Authority to reconduct the written examination. Accordingly, the KEA reconducted the written examination on 23.01.2024 vide reference (7). After completing the evaluation of answer sheets, the KEA vide reference (8) published the Final Marks List on 28.03.2024.

5. Vide this office letter cited at reference (9), clarification was sought from the Government regarding preparation of Provisional Select List. In this regard, vide reference (10), the Government of Karnataka issued a direction as follows:-

6.2 ಆಯ್ಕೆ ಪಟ್ಟಿಯನ್ನು ಪ್ರಕಟಿಸುವ ಸಂದರ್ಭದಲ್ಲಿ ಈ ಆಯ್ಕೆ ಪಟ್ಟಿಯು ಮಾನ್ಯ ಉಚ್ಚ ನ್ಯಾಯಾಲಯವು ರಿಟ್ ಪಿಟಿಷನ್ ಸಂ:16343/2024ರಲ್ಲಿ ನೀಡುವ ಅಂತಿಮ ತೀರ್ಪಿಗೊಳಪಟ್ಟಿರುತ್ತದೆಂದು ಹಾಗೂ ಈ ಆಯ್ಕೆ ಪಟ್ಟಿಯಲ್ಲಿ ವೃಂದ ಬದಲಾವಣೆ, ಮೀಸಲಾತಿ ಪ್ರವರ್ಗ ಬದಲಾವಣೆ, ಅರ್ಹತಾ ಪಟ್ಟಿಯಲ್ಲಿನ ಸ್ಥಾನ ಮತ್ತು ಘಟಕಗಳ ಬದಲಾವಣೆ ಆಗುವ ಸಾಧ್ಯತೆಗೊಳಪಟ್ಟಿರುತ್ತದೆ ಎಂಬ ಷರತ್ತುಗಳನ್ನು ವಿಧಿಸುವುದು."

7. In accordance with Government letter cited at referenced (10), a provisional select list of 505 candidates was prepared and published in the departmental official website on 21.10.2024, as per reference (11). subsequently, the unit-wise provisional select list cited at reference (12) was prepared and sent to concerned units to conduct the medical examination and document verification for the selected candidates as per cadre and recruitment rules and to submit the report to this office.

8. Considering that the Civil Police Sub-Inspector posts involve a foundational training period of 12 months, to facilitate timely training, it has been proposed to grant permission for issuing appointment orders to the eligible candidates (who have been selected as per the provisional select list of 505 Civil PSI posts and have completed medical examination and document verification), subject to the condition that the seniority shall be fixed according to their rank in the selection list as per Rule 5 of the Karnataka Government Servants (Seniority) Rules, 1957 vide cited at reference (13).

9. In this regard, Government letter referenced in (14) states that the Civil Police Sub-Inspector post is essential for maintaining law and order and for crime control. Therefore, it has been directed that, subject to the following conditions, permission shall be granted to issue appointment orders to the eligible candidates who have been selected as per the provisional select list and have completed medical examination and document verification, in order to facilitate the early commencement of professional foundational training.

- 9.4) ಎಲ್ಲಾ ಅಭ್ಯರ್ಥಿಗಳ ವೈದ್ಯಕೀಯ ಪರೀಕ್ಷೆ ಮತ್ತು ದಾಖಲಾತಿ ಪರಿಶೀಲನೆಯು ಪೂರ್ಣಗೊಂಡ ನಂತರ ಕ್ರೋಢೀಕೃತ ಮತ್ತು ಘಟಕವಾರು ಅಂತಿಮ ಆಯ್ಕೆ ಪಟ್ಟಿಯನ್ನು ಪ್ರಕಟಿಸುವುದು.”

10. Accordingly, a total of 492 candidates have been issued appointment orders so far, out of which 460 candidates are currently undergoing foundational training at the Karnataka Police Academy, Mysuru and the Police Training Centre, Kalaburagi.

11. As per Cadre & Recruitment rules, the second provisional select list of 502 candidates who have been declared eligible in the medical examination has been sent to the respective units as per reference (15).

12. Since the case of Mr. Sagar Babu Satwar (Writ Petition No. 16343/2024) is still pending before the Hon'ble High Court of Karnataka, and as 40 posts in the Kalyana Karnataka cadre have already been reserved in accordance with Government letter cited at reference(9), a proposal has been submitted to the Government vide reference (16) seeking legal opinion and further instructions regarding considering those 40 reserved Kalyana Karnataka candidates for selection and issuing of appointment orders.

13. In this regard, Government letter cited at reference(17) directs to issue appointment orders based on the following points and take necessary steps to complete the recruitment process in accordance with the Police department cadre and recruitment rules with regard to direct recruitment of PSI (Civil) 545 & 402 posts.

14. The published provisional list will be subject to the above conditions. In addition, the list shall also be subject to the following terms, **and the previously reserved 40 Kalyana Karnataka candidates have been marked with (*)**.

- This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.
- The fact that the name of the candidate figures in this list does not give him/her any legal right for appointment to the post, which is subject to the conditions.
- This select list is subject to the final decision if any, of the the Hon'ble Karnataka State Administrative Tribunal / the Hon'ble High Court of Karnataka / the Hon'ble Supreme Court of India.
