**PROVISIONAL SELECT LIST**

1. In pursuance to the Notification cited at reference(2), the recruitment process to fill up 80 posts of Police Constable (Civil) (Men & Women) and 20 posts of Sub-Inspector of Police (Civil) (Men & Women) including In-Service and Kalyana-Karnataka was initiated by adhering all the procedures laid down in the Cadre and Recruitment Rules, published vide Government Notification cited at reference(1). As per the recruitment notification applications from the eligible candidates were invited through online from 31.08.2021 to 29.09.2021.

2. Whereas, as laid down in the Cadre and Recruitment Rules, the selection of the candidates for the above posts has to be made by the committee duly constituted for the same. Accordingly, a meeting has conducted on 29.03.2022. After taking into consideration the views of the experts in the selection committee the provisional select list of the successful candidates for the post of Police Constable (Civil) (Men & Women) and Sub-Inspector of Police (Civil) (Men & Women) including In-Service is prepared and published at reference(3).

3. After this 10 candidates (08 PC's & 02 PSI's) candidature has been rejected due to submission of their invalid caste and income certificate in the application, unwillingness to join the said post, Medically unfit and non-genuinity of the sports certificates, as per the decision taken by the experts in the selection committee cited at reference(4). Hence their candidature has been cancelled vide reference(5) and published provisional select list of new 10 candidates vide cited at reference(6).

4. Due to the cancellation of the candidature of 10 candidates (08 PC's & 02 PSI's) namely (S.B.Supriya. Appl.No:7500145), (Kavya shree.V. Appl.No:7500157), (Nikshep. B.R. Appl.No: 7500504), (Sandhya.K.K. Appl.No:7500099), (Prakyath Shetty.N. Appl.No:7500075), (Nandish.A. Appl.No:7500629), (Sumanth.M.M. Appl.No:7500161), (Malappa Hanamantha Kuduchi Appl.No:7500194) (Tejas.K. Appl.No:7300145) and (Sandesh Uppar. Appl.No:7300066) 10 posts in Meritorious Sports persons of Police Constable (Civil) and Sub-Inspectors of Police (Civil) has remained unfilled. In order to fill up 10 posts, this Provisional Select List is being published with the following conditions.

- This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules and the verification of all the documents including the Character and Antecedent.
- The fact that the name of the candidates figures in this list does not give them any legal right for appointment to the post which will be dependent on the aforesaid condition.
- This select list is subject to the final decision of the Hon'ble Karnataka State Administrative Tribunal / Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
